3 TEAM POOL PLAY: Best 2 out of 3 sets 27 pt Cap . 3rd set to 15 with 17 pt cap. 23 pt cap After Match 3 20 minute Break regroup and play 2nd round. Teams will be ranked by over all record. Libero Serves.

WARM-UP FORMAT: First team listed has the net first. Shared courts for ball handling first 2 minutes only first 2 matches. Don't wait for refing team to start warmups but refing team should be on the court immediately after the end of each match.

OFFICIATING: A coach must either officiate up or down each match. Refer to schedule for pool play. The team assigned to referee is responsible for starting all matches on time. **Stop watches provided so no electronic devices on the court at any time. this includes coaches. PLAYOFF OFFICIATING:** Check posted brackets. Check in with the site director before leaving to make sure your officiating duties are fulfilled.

PLAYOFFS: Best 2 out of 3 sets to 25 no cap must win by 2pts 3rd set to 15 pts.. Top 3 teams advance to the Gold Division Medals awarded to the 1st Place Team. The rest advance to the Silver Division, medals awarded to the 1st Place Teams. If there are two way ties, the tie breaker is head to head results. If there is a 3 way tie, teams will be ranked by set percentage (number of sets won divided by the total played) final determiner will be point differential.
